Aesculap AG has received customer feedback that the assembly of Enduro Tibia components and the replacement of the PE gliding surfaces can lead to the bending or breaking of the metal pins of the tibial locking ring key.

This bending or breaking of the metal pins on the tibial locking ring key is the result of a possible tilting of the NP462R or NP454R wrench during use.

As part of ongoing product improvement, the system has been modified and added. Assembly and changing the PE sliding surfaces was simplified by the use of the new modified instrument NQ839R in combination with NP144PM and NP141R (only in combination with the modified version of the wrench NP462RM). The NQ839R - ENDURO TIBIA PLATEAU HOLDING KEY makes it easier to hold the tibia components in place when changing the PE gliding surfaces (including the axis components). Tilting of the wrench during use is prevented.

Please check that the instruments you are using are the latest versions. Please only use these new versions in the future. In the table below you will find an overview of the modified and added system instruments. In order to also avoid the scenario described above when using the NP454R, Aesculap AG recommends to use this tibial locking ring key only in combination with the new modified instruments.

A detailed description of its use can be found in the operating technique instructions O38602.

If you do not yet have the latest version of the instruments at your facility, please contact our product management to organize an exchange. If required, Aesculap AG will provide a new storage tray and a corresponding packing template.

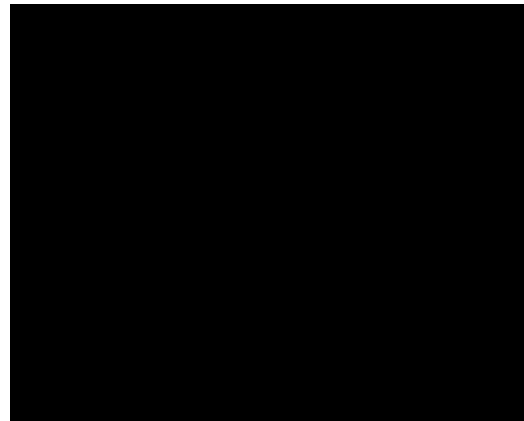
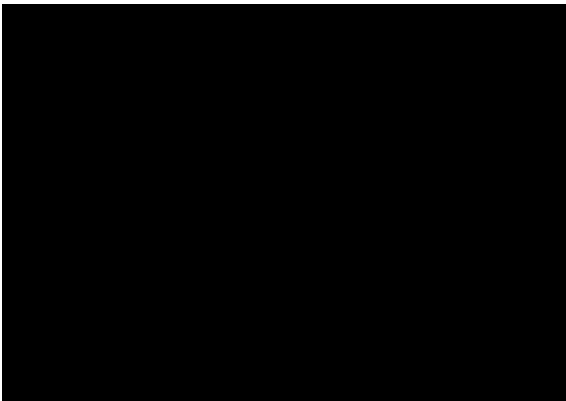
