Urgent Field Safety Notice

Dear Customer,

This letter is to inform you of a voluntary Field Safety Corrective Action (FSCA) which affects a limited number of consoles for the VERSAJET⁰ II Hydrosurgery System (the VERSAJET System), manufactured by Smith & Nephew Inc. USA and Smith & Nephew Medical, United Kingdom. This FSCA requires device modification/exchange in order to ensure compliance of a component in the affected consoles with the European Directive for Restriction of Certain Hazardous Substances (RoHS). Affected devices do not present any safety risks to patients.

Background

Directive 2011/65/EU (the RoHS directive) requires that certain medical device Electrical and Electrical Equipment (EEE) placed on the market after July 22, 2014 complies with restrictions on a number of hazardous substances.

Smith & Nephew became aware that a number of consoles of the VERSAJET II System contain a component whose lead (Pb) content may exceed the limit set in the RoHS Directive. The component in guestion is sealed inside the affected consoles, and does not come into contact with patients and/or with users.

Smith & Nephew is taking the necessary corrective actions to bring the VERSAJET II System consoles into conformity with the RoHS Directive. To that end, the following actions are being initiated:

- 1. Voluntary non safety related removal of the affected consoles from the market; and
- Replacing affected consoles for a compliant system or issuing credit to customers. 2.

For avoidance of doubt, based on our safety assessment, the non-RoHS compliant bearing does not present any safety concerns for patients or end-users of the consoles.

RoHS compliance is also required to complete the necessary conformity assessment procedure for the VERSAJET system.

This FSCA is being reported to the relevant Competent Authorities.

Context and reasons for this FSCA

- 2. Complete the return slip and forward it to your national Smith & Nephew agency / distributor to confirm receipt of this Field Safety Notice.
- 3. Ensure this information is passed on to all those who need to be aware of it within your organization.
- 4. Maintain awareness of this notice and resulting action for an appropriate period to ensure effectiveness of the corrective action.
