## UPDATED URGENT FIELD SAFETY NOTICE

Valleylab™ Laparoscopic Handset, Four-Function

May 1, 2017

### Attention: Risk Management Director and O.R. Materials Management

Dear Valued Customer:

The purpose of this letter is to advise you of an update to our February XX, 2017, communication related to Medtronic's Field Safety Corrective Action (FSCA) for specific production lots of its Covidien Valleylab<sup>™</sup> laparoscopic handset, four-function (Item Code: E2750). This update is related to additional lots being added to the FSCA. The additional lots are listed below.

This FSCA is being conducted following customer reports of the Valleylab<sup>™</sup> laparoscopic handset continuing to operate after release of the activation button. If the device continues to operate after deactivation by the user, it can increase the potential for internal tissue burn/damage. There have been no reports of serious injury associated with this FSCA.

Medtronic requests that you quarantine and return any unused products of the lots detailed below. Unused products from the affected lots should be returned as described in the Required Actions section below. If you have distributed the Valleylab<sup>™</sup> laparoscopic handset listed below, please promptly forward the information from this letter to those recipients. All unused products from the affected lots must be returned.


