- Cardinal Health™ Fabric-Reinforced Surgical Gowns
- RoyalSilk® Non-Reinforced Surgical Gowns

Dear Valued Customer:

The purpose of this letter is to advise you that Cardinal Health is voluntarily recalling specific production lots of single-sterile and bulk non-sterile Cardinal Health™ Non-Reinforced Surgical Gowns, Cardinal Health™ Fabric-Reinforced Surgical Gowns and RoyalSilk® Non-Reinforced Surgical Gowns. The affected gowns were distributed between September 1, 2018 and January 10, 2020. Note that gowns manufactured prior to 2018 are <u>not</u> affected by this recall.

Issue Description

Cardinal Health is conducting this recall because some of the affected gowns were manufactured at locations that did not maintain proper environmental conditions as required by law, were not registered with the FDA, were not qualified by Cardinal Health and commingled with properly manufactured gowns. As a result, Cardinal Health cannot provide assurances that the identified item codes and lot numbers were properly sterilized. An improperly sterilized surgical gown could compromise a sterile field and increase the risk of a surgical site infection.

Cardinal Health is initiating this voluntary recall on the item codes and lot numbers in the following four (4) tables. Refer to Exhibit A for more information on identifying affected lots.

Required Actions:

1. **Check** all storage and usage locations to confirm if you have any units of the affected item codes and lot numbers in your possession. Exhibit A explains how to identify affected gowns.

Distributors – In the event your company has included affected gowns as components in convenience kits, we advise that you assess the impact of this recall on those kits.

- 2. **Review, complete, sign and return** the enclosed Acknowledgement Form by following the directions on the Form.
- 3. **Return** product labeled as shown in <u>Exhibit A</u> or contact your local sales representative to facilitate return of the affected gowns. Your local sales representative will inform you of either product replacement or credit options.
- 4. **Share** this notice with others in your facility who need to be aware of this removal. Contact other facilities that may have received units of affected lots.
- 5. **Maintain awareness** of this notice until all affected product has been returned to Cardinal Health.
- 6. **Keep** a copy of this notice with affected product until returned to Cardinal Health.

Cardinal Health is notifying the appropriate regulatory authorities of this voluntary field action. We request that you contact Cardinal Health if you have experienced quality problems or adverse events. We sincerely apologize for any hardship this field action may have caused your staff and patients.

In order to determine the date of manufacture, refer to the lot number formatting below:
