Reason for Field Correction

Siemens Healthcare Diagnostics is conducting a corrective action for the MicroScan WalkAway plus instruments to address a potential failure with the access door hinge. The failure can cause the springs to dislodge and be ejected towards the operator causing a potential safety issue for the customer. This notification is to inform you of the potential for injury to the WalkAway instrument operator if the access door hinge failure occurs when accessing the WalkAway plus instrument through the front access door.

Risk to Health

This failure does not impact patient results; therefore it is not necessary to review previous test results or to repeat testing.

This failure may result in bodily injury to the user. The severity of the injury ranges from minor or more serious depending on the body site involved and the proximity to the hinge at the time of failure.

An additional risk may be the exposure to reagents or inoculated panel fluids if the operator is adding or removing panels from the instrument at the time the springs are ejected.

Actions to be Taken by the Customer

 Wear personal protective equipment (PPE), including eye protection when accessing the WalkAway plus instrument through the front access door. Information Regarding MicroScan WalkAway plus Access Door Hinge

- Take caution when loading and unloading panels or performing maintenance or other activities through the WalkAway plus access door.
- · Discuss the content of this letter with your laboratory director.
- Complete and return the Field Correction Effectiveness Check attached to this letter within 30 days.

A Siemens representative will contact you over the next few months to schedule a visit to correct this issue with the access door hinge. Please retain this letter with your laboratory records, and forward this letter to those who may have received this product.
