	Aim of the criteria is to have a standardized emergency mental health triage criterion across NGOs that refer to hospital admission to:					

o Determine highest priority cases

- Facilitate access
- o Eliminate delays
- o Decrease the risk of self-harm and suicide.
- ➤ The Triage Criteria for Persons with Mental Health Conditions in Need of Hospitalization are designed as a tool to be used by the psychiatrist in humanitarian field and public sector to support in decision-making through:
 - Providing a standardized approach to determine need and the urgency for inpatient care
 - Clarifying prioritization of referrals of persons to psychiatric admission, with the aim to ensure timely referral to needed care.
 - o Ensuring that responses are appropriate to the person's level of risk
 - Providing a structured approach to document and facilitate the process of prioritizing persons to be admitted for inpatient psychiatric care, and record the needed information for referral and follow-up
 - Providing a basis for improved communication between the mental health professionals (psychiatrists at NGOs) who do the triage and other services (psychiatrists at psychiatric hospitals).
