MHPSS Monthly Indicators Version 1.4 (Initial Use - September 2018)

The Mental Health and Psycho-Social (MHPSS) Monthly Indicators are designed as a minimum set of data points to monitor the access and some quality components of the available MHPSS services in Lebanon. They focus on the provision of core MHPSS activities along with follow-up questions regarding specific vulnerable subgroups of the population (e.g. presence of suicide risk, psychosis, and referral to hospitalization).

These indicators were selected based on available indicators shared by different organizations participating in the MHPSS Task Force, advice from local and international stakeholders and experts in the field. In addition, discussions and feedback received from those involved with reporting for the MHPSS Monthly Indicators helped develop the current version (1.4) of the form.

The main goals of the MHPSS Monthly Indicators are:

- Monitor access to doctors trained on Mental Health Gap Action Program (mhGAP), both psychologists and psychiatrists
- Monitor the trend of mental health diagnosis in Lebanon
- Follow-up on specific vulnerable populations and decrease risk of relapse and suicide
- Empower persons with mental health disorders and their caregivers

Active person	Person not being formally discharged from the facility for a mental health episode and interacting with the mental health service of the facility at least once within the last 3 months
Discharged person	The person with mental health disorder is considered officially discharged for this mental health episode when it is formally agreed with the person that there will not be any interaction with the facility
Defaulter person with psychosis	A defaulter person with psychosis is a person with psychosis not officially discharged and not interacting with the facility even once within the last 3 months (either by phone or home visit or for medications or for consultation)
Mental health diagnosis	Mental health diagnosis is based on International Classification of Disease ICD10
Suicide risk	As per mhGAP suicide risks criteria[1]
